If requested by Runza® National, Inc., I agree to supply statements from my professional advisors verifying the disclosed assets, and I also agree to furnish copies of Federal Income Tax Returns as filed for the last five years. #### Confidentiality and Non-Disclosure Undertaking

The individual who has submitted this Franchise Application ("Applicant") has applied to become a franchisee of Runza® and, in connection with the application process, may become privy to certain information regarding the business of Runza® and its franchisees which Runza® classifies and protects as confidential and proprietary (the "Information"). Runza® is willing to divulge such information (as and to the extent it deems appropriate in connection with the Applicant's application) only if the Applicant agrees to protect the confidentiality of such Information. In consideration of the disclosure of Information, Applicant agrees to the following terms and conditions:

1. <u>Confidentiality.</u> Applicant, on behalf of itself and its affiliates, employees, officers and directors, agrees to maintain as confidential all Information disclosed to it. - 4. <u>Breach.</u> Any breach of provision hereof will be theft of Runza® trade secrets, and will cause irreparable harm and damage to Runza®. Runza® shall be entitled to enjoin any actual or threatened violation of any of the provisions in this Agreement. In addition to injunctive relief, Runza® may recover damages from Applicant for any loss caused by any violation of the provisions of this Agreement (including violations by third parties to whom Applicant discloses information). In any action brought to enforce any of the provisions of this Agreement, Runza® shall be entitled to reasonable attorney's fee and costs.
